## RIGHTS OF THE DATA SUBJECT - COMPLAINING TO THE SUPERVISORY AUTHORITY

By contacting the Data Controller by e-mail at <a href="mailto:dataprotection@arc-gas.it">dataprotection@arc-gas.it</a> data subjects may ask the Data Controller to allow access to data concerning them, their correction, integration or their cancellation, as well as the limitation of processing in the cases provided for by art. 18 GDPR as well as oppose processing in the hypotheses of legitimate interest of the Controller.

Furthermore, if the data processing is based on consent or on the contract and is carried out with automated tools, data subjects are entitled to receive the data in a structured, commonly used and automatically readable format, as well as, if technically feasible, to transmit them to another controller without impediments.

Data subjects have the right to lodge a complaint with the competent Supervisory Authority in the Member State in which they normally reside or work, or in the State in where the alleged breach took place.
